

2009 FREE SIGN PROGRAM

May 1st to September 1st

The guidelines for participation in Free Sign Program are as follows:

- Signs must be "A", "H" or "T" frame.
- Signs must be stored indoors during non-business hours.
- Signs are limited to a maximum 10 sq. ft. per side
- Signs must be placed in an approved location as determined by the Village Administrator
- Signs must remain in good repair.
- Signs cannot be lighted
- Signs cannot be placed in the right of way.
- Available to businesses located in the **Downtown Core** and **Downtown Support Districts** (DC and DS)
- Other advertising options will be discussed and considered!

In the event the guidelines are not followed, the following will be followed.

- 1.st Written Notice to comply
- 2.nd Written Notice to comply
- 3. Revocation of Permit
- 4. Citation to Mayor's Court for NON-COMPLIANCE
